



# HISTORIC PAINT PROGRAM DISCOUNT APPLICATION

Sponsored by Classic Paints, Mid-South Paint & Design, Porter Paints, and the Historic Preservation Board

The Historic Paint Program offers deeply discounted (better than “contractor’s rate”) exterior paint for qualifying historic properties. *This project does not dictate paint color, quality or type.*

This is a special incentive that three local paint stores are offering for historic properties.

## Qualifications:

- The HPB will take applications from February thru November.
- All projects must be completed by December 1<sup>st</sup>
- The project is for exterior paint projects only.
- Property must be listed in the National Register OR have Local Historic Designation OR be in the process of either designation. Visit [www.warrenpc.org](http://www.warrenpc.org) for maps of districts, properties individually listed in the NR can be found at <http://www.nr.nps.gov/>.
- Property must be located in Bowling Green or Warren County
- Applicant must be property owner
- Project may be completed by property owner or licensed contractor
- Owners of multiple properties may apply for discounted paint for up to three projects. (A main building and its out buildings would be considered one project.)
- Applications for painting unpainted masonry of structures with Local Historic Designation must have a COA before applying for this program. (Applications may be submitted together.)

## Requirements:

- Completed application form
- Photograph of each side of the structure(s) to be painted. Photographs will be accepted in any format except slides.

## Review:

Completed applications will be reviewed within five days of receipt.

## Paint Prices & Info:

Call or visit each of the three participating companies to compare prices, colors, and quality to obtain the right paint for your project. You must receive a certificate from the HPB to qualify for this discount.

## ADDITIONAL INCENTIVES

**Bowling Green City Tax Moratorium.** The Tax Moratorium is an economic incentive program providing tax abatement to owners of rehabilitated residential or commercial properties within the Bowling Green city limits. This incentive is in the form of a five-year tax moratorium on city real estate taxes on the rehabilitated portion of the property.

**Federal Tax Credit.** Provides a 20% tax credit for income producing properties that can be spread out over five years. Project must be at least \$20,000. For more information visit [www.cr.nps.gov/hps/tps/tax/](http://www.cr.nps.gov/hps/tps/tax/)

**State Tax Credit.** Provides a 20% tax credit for income producing properties and 30% for owner-occupied residential properties. (The Federal form can be used to apply for both the Federal and the State credits.) For more information visit [www.preservationkentucky.org](http://www.preservationkentucky.org)
