**Transportation Improvement Program (TIP) FY 2016-2020  
Amendment #2018.02**

**ACTION:**

The Bowling Green-Warren County Metropolitan Planning Organization (MPO) hereby amends the FY 2016-2020 Transportation Improvement Program (TIP) to reflect project phases and funding from the Enacted 2018 Kentucky Highway Plan in the biennium and beyond. This amendment moves projects from the Informational Supplement portion of the TIP to the Federally Funded portion and adds new projects under each section (Federally Funded, State Funded - Regionally Significant, and Informational Supplement). The funding revisions related to these amended projects are highlighted in the tables and information provided on the following pages.

Other Information: Additional funding beyond that previously identified in the TIP, has been committed to these projects by the Federal Highway Administration and the Kentucky Transportation Cabinet. Therefore, as reflected in the amended Table 1, the MTP and the TIP remain financially constrained with these amendment changes.
